**Resolution Accepting Draft Generic Environmental Impact Statement In
SEQRA Review Of The Town's Comprehensive Plan Update And Setting a Public
Hearing Upon It**

At the Regular Meeting of the Town Board of the Town of Fishkill, Dutchess County, New York, held at Francois R. Cross meeting room, 807 Route 52, Fishkill, New York, on the day of February 15, 2023 at 7:00 P.M.

The following Resolution was introduced by Supervisor Albra and seconded by Council Member Istvan.

WHEREAS, the Town Board of the Town of Fishkill has undertaken preparation of an update to the Town's Comprehensive Plan ("CPU"); and

WHEREAS, the adoption of the CPU is an action subject to review under the New York State Environmental Quality Review Act ("SEQRA") ECL §8-0101 et seq. and 6 NYCRR Part 617; and

WHEREAS, a positive declaration has been made in regard to SEQRA review of the CPU; and

WHEREAS, the Town Board has prepared and accepted a scope for a Draft Generic Environmental Impact Statement ("DGEIS"); and

WHEREAS, the Town Board has caused a DGEIS to be prepared;

NOW THEREFORE BE IT RESOLVED, as follows:

1. That the Town Board, as Lead Agency in SEQRA review, hereby accepts the DGEIS as complete; and

2. That a copy of the DGEIS in electronic format shall be sent to the Department of Environmental Conservation, Division of Environmental Permits, 625 Broadway, Albany, NY, 12233-1750; and

3. That a notice of completion of the DGEIS shall be posted on the Town's website, posted on the Town Clerk's Bulletin Board, published in the Environmental Notice Bulletin, and filed with the Town Supervisor and the Town Board; and

4. That the Town Board hereby schedules a public hearing on the DGEIS for March 15, 2023 at 7:00 p.m.; and

5. That notice of the said public hearing shall be published in the Town's paper of record and posted upon the Town's website not less than fourteen (14) days prior to the public hearing date and shall be posted on the Town Clerk's bulletin board; and

6. Notice of the said public hearing will be mailed to all identified interested agencies; and

7. That copies of the DGEIS shall be made available for review by the public in the Town Clerk's Office and posted on the Town's Website.
