PROPOSAL AND BID FORM TOWN OF FISHKILL

Specifications: R.O.B. Gravel, Washed Gravel, Washed Sand. Will be clean and well graded; subject to the approval of the Town Superintendent of Highways.

Prices are to be submitted per ton and/or per cubic yard F.O.B. bidder's plant and stockpiled within the Town of Fishkill. These prices are for the years January 1, 2023 to December 31, 2025 (two years)

Length of haul, quality, and availability of product will be considered in awarding this business and the right is reserved to reject any or all bids.

Under this section the Town of Fishkill reserves the right to select the source of supply for all materials that must be hauled or transported to the job site utilizing DPW forces and equipment. The Town shall have the right to control the ordering and selection of all materials items, and source of materials, whereas overall activities are the mandated requirements. The Town will place orders and purchase materials, only where an analysis of requirement indicates the lowest composite cost to the Town. Generally, materials shall be purchased from the approved contract plant or contract supplier located nearest the project or job site in terms of location of the DPW organized work activity or project plant/source; the required hauling distance; the contract bid routing; the most acceptable transport route in terms of highway, bridge and equipment safety. The foregoing factors shall be analyzed in determination of the lowest composite or lowest cost the Town and the resulting source selection. The Town DPW reserves the right to order and purchase from an alternate approved contract supplier if a designated contract supplier is unable to supply the specified materials, or the necessary amount or volume of materials required by the Town on any particular day or within any particular or specified time frame.

The Town of Fishkill has the right to reject any and all bids. A Non- Collusive must be attached to all bids.
