Friendly Paws Park Permit Application

WAIVER AND HOLD HARMLESS
TOWN OF FISHKILL DOG PARK

In consideration of the Town of Fishkill (the "Town") granting permission to the undersigned to bring my dog to the Dog Park of the Town, the undersigned hereby agrees to assume all liability and all risk of loss and shall be responsible for the supervision and welfare of all persons and/or dogs arriving on and/or using Town property and/or facilities in connection with permit issued. The undersigned hereby acknowledges that I have voluntarily applied to participate and use the Town of Fishkill Dog Park and understand that the acts of unleashing my dog or being physically present inside the Town of Fishkill Dog Park necessarily involves risks of injury to me, other people, my dog(s) and other dogs, including but not limited to, risks resulting from aggressive or dangerous dogs, unpredictable behavior, lack of training, and lack of vaccination.

The undersigned further hereby releases the Town of Fishkill, its officers, employees, servants, agents and enumerated volunteers from any liability for any injuries sustained, or damages incurred and to reimburse the Town for any damages either arising out of or directly or indirectly in connection with the undersigned's use of the Town property and/or facilities. The undersigned hereby further agrees that I will indemnify and hold harmless the Town of Fishkill, its officers, employees, servants, agents and enumerated volunteers harmless from any liability or claims that may result from any use by me and/or my dog of the Town property and/or facilities arising out of this permit.

The undersigned represents that any dog listed on the application is at least six (6) months old and has been licensed, de-wormed, vaccinated as required. The undersigned also represents that no dog listed on the application has exhibited aggressive or dangerous behavior and the undersigned has no personal knowledge that said dog (s) has ever bitten another person or dog.

Friendly Paws Dog Park Rules and Permit Conditions

1. All owners of dogs must provide proof of current vaccinations against rabies and proof of current licensing and Dog Park Permit.
2. All dogs must wear identification tag.
3. Owners are solely responsible for the actions of their dogs and shall be responsible for preventing their dog from aggressive acts against other persons or dogs.
4. Female dogs in heat are prohibited.
5. Dogs cannot be tied to benches, fences, or light poles
6. Dogs that have been declared dangerous or aggressive are prohibited.
7. Dog fecal matter must be cleaned up by the dog owners and put into the proper receptacle.
8. Dog owners must be in fenced area with their dogs under visual contact and oral commands when not on a leash.
9. Dog owners must immediately fill any hole their dogs dig.
10. Dogs must be leashed when entering and exiting the Dog Park.
11. Dog owners must have a leash readily available at all times.
12. No smoking or human food allowed in the Dog Park.
13. Small bite sized treats are allowed.
14. Any children 12 years old and younger may accompany the family pet only if they are under direct supervision of an adult.
15. All persons bringing a dog into the Dog Park must have a Town Permit. Fees for such Dog Park permits are non-refundable.

Enforcement

These Rules and Permit Conditions may be enforced by the Town of Fishkill Town Supervisor, Code Enforcement Officer, Dog Control Officer, and any law enforcement officer.

Penalties

A violation of these Rules shall constitute a violation under Chapter 58 of the Town of Fishkill Town Code and shall be punishable as an offense under Chapter 58 of the Town Code in addition to the penalties set forth below:

A person entitled to enforce these Rules and Permit Conditions of the Dog Park may suspend or revoke a permit and/or may direct any person and their dog to leave the Dog Park.

In addition to any other applicable penalties under the Town Code, a first violation of these Rules and Permit Conditions or a violation of Chapter 58 of the Town Code shall subject the permit holder to a six-month suspension of their permit. Where the violation resulting in suspension of the permit arose from aggressive or reckless conduct by the permit holder's dog, such permit shall not be reinstated until proof of completion of a dog obedience course to be completed after the date of the incident resulting in the suspension of the permit.

In addition to any other applicable penalties under the Town Code, a second violation of these Rules or Permit Conditions or a violation of Chapter 58 of the Town Code shall subject the permit holder to a twelve-month suspension of their permit. Where the violation resulting in suspension of the permit arose from aggressive or reckless conduct by the permit holder's dog, such permit shall not be reinstated until proof of completion of a dog obedience course, to be completed after the date of the incident resulting in the suspension of the permit.

In addition to any other applicable penalties under the Town Code, a third violation of these Rules or Permit Conditions or a violation of Chapter 58 of the Town Code shall subject the permit holder to a permanent revocation of their permit and a ban from the Friendly Paws Dog Park.
